TOURISM INDUSTRY : KEY TO FASTER ECONOMIC GROWTH

The tourism industry of India is economically important and is growing rapidly. It has become the world's fourth largest export industry after fuels, chemicals and food. Specifically, tourism accounts for 6 per cent of the world's total merchandise and service exports that represents 30 per cent of international trade in services. Besides, 9.8 per cent of the world's total gross domestic product (GDP) originates from the tourism sector. The influence of inbound tourism on national economies is becoming increasingly important because of the growing size of the tourist market. Inbound tourism stimulates economic growth in numerous ways. For instance, tourism significantly contributes to foreign exchange reserves which help in bringing new technologies for production process. Secondly, tourism stimulates investments in new infrastructure, human capital and increases competition. Thirdly, tourism promotes industrial



development through spillover effects and creates jobs and hence stimulates earnings, thereby generating positive economic externalities.

India is one of the fastest growing economies in the world, which implies that its tourism industry can be expected to grow faster in the years to come. There is a large untapped potential in the Indian tourism industry. In fact, UNWTO noted that India recorded the strongest growth in international tourists

arrival during the last decade. India offers myriad options in tourism, for example: 36 world heritage sites and 103 national parks, plus the Taj Mahal in Agra, Rajasthan's hill forts, the holy city of Varanasi, and everything else in between the mountains of the Himalayas like Utrakhand, HP, Jammu Kashmir, whole of North East and the beaches of Goa. Add to it the jungles with tigers, elephants, and the last of Asia's lions, no other country is better suited to take advantage of an

adventure travel market that is expected to grow to \$1.3 billion by 2023.

Tourism is an important economic activity in most countries around the world and it has significant indirect and induced impact on economy. Indian Tourism offers mixture of different cultures, traditions, festivals, and places of interest. There are a lot of options for the tourists. India is a country with rich cultural and traditional diversity. The different parts of the country offer wide variety of interesting places to visit. The positive economic effects of tourism are seen in the economy such as its contribution to the generation of national income, expansion of employment opportunities, rising of tax revenue, generation of foreign exchange and transformation of regional economy.

It has been noticed that Hotel occupancy levels in India are at their highest levels since 2008, even though many hotel chains have raised prices. The need for

rooms has been identified by foreign investors with Japan's Soft Bank Group backing start-ups like OYO Rooms, which has emerged as the largest aggregator of budget accommodation across the country with hotels in over 200 destinations. One major driver of the domestic tourism boom has been the launch of five regional budget airlines on over 100 routes, which have been given incentives to offer cut-price flights to uncovered and remote areas, encouraging thousands of families to explore flying for the first time. With the result, domestic airlines carried 10.6 million passengers in the first eleven months of 2017, up 17% from the year-ago- encouraging some established players like Spicejet, Jet Airways and Vistara to start flights to new locations.

At the same time, over 9 million foreigners visited India in the first 11 months of 2017, up 15.6% from a year ago. Domestic tourists, who account for 88% of the sector, are increasingly using

MEDICAL CODING: AN EMERGING CAREER

Some time back, I had an interesting career query from a young, bright student of class XII who opted for Physics, Chemistry, Biology (PCB), as he came from a family of doctor's, and surprisingly didn't want to be doctor. He was not aware of any upcoming or new age careers in PCB other than Medical. While exploring other options for a career he came across "Medical Coding" which sounded appealing to him. He had heard about it once, but he had a very limited knowledge about this field. So many questions popped up into his mind, like what is Medical Coding? Is it same as Medical Billing? Are there courses available in this area? What qualifications are required to be a Medical Coder? So I decided to write this article which throws light on this promising field.

Nowadays there is an extraordinary rise in the career opportunities available in the different fields. A lot of new opportunities are arising in the Indian job market. Medical



coding is an upcoming in-demand field in the stream of Healthcare Administration. Among the various upcoming career opportunities; Medical Coding is also a very good career option for the youth of our country. With the growth of the various sectors, healthcare sector is also witnessing a sudden growth in our country. This sector is generating millions of jobs not only in India and United States but also in other

developed and developing countries.

CAREER OVERVIEW- What is Medical Coding all about?

In simple terms, Medical coding is the translation of medical reports into a short code used within the healthcare industry. This helps summarize otherwise cumbersome medical reports into efficient, data-friendly codes. These code sets help coders document the condition of a patient and

describe the medical procedure performed on that patient in response to their condition. It is an important process in medical billing and plays a vital role in overall reimbursement cycle.

WHY IS MEDICAL CODING IMPORTANT?

Medical billing and coding employees are essential and crucial for success of healthcare facilities and providers. They rely on the expertise of medical coding and billing individuals to assist in billing of services provided to their patients and processing of claims. The diagnoses and procedure codes are taken from medical record documentation, such as transcription of physician's notes, laboratory and radiologic results, etc. Medical coding professionals help ensure the codes are applied correctly during the medical billing process, which includes abstracting the information from documentation, assigning the appropriate codes, and creating a claim to be paid by insurance carriers.

IS MEDICAL CODING THE SAME AS MEDICAL BILLING?

The answer is No. Medical coding and medical billing are two separate processes. The main task of a medical coder is to review clinical statements and assign standard codes. Medical billers, on the other hand, process and follow up on claims sent to health insurance companies for reimbursement of services rendered by a healthcare provider. The medical coder and medical biller may be the same person or may work with each other to ensure invoices are paid properly. To help promote a smooth coding and billing process, the coder checks the patient's medical record (i.e., the transcription of the doctor's notes, ordered laboratory tests, requested imaging studies, and other sources) to verify the work that was done. Both works together to avoid insurance payment denials.

WHAT MEDICAL CODERS DO?

Medical coders play a vital role in the connection between health care providers, patients and insurance companies. As a coder, you'll need to read patient charts to determine medical history, including diagnoses and treatments given. Based on these charts, you'll use a set of established medical codes in order to transcribe patient history into a type of "shorthand" that will be used by both health care providers and insurance companies.

From clinics to hospitals to physicians' offices, medical coders use medical codes to document patient diagnosis and treatments. Specifically, their duties include:

- ♦ Reading and analyzing patient records
- ♦ Determining the correct codes for patient records
- ♦ Using codes to bill insurance providers
- ♦ Interacting with physicians and assistants to ensure accuracy
- ♦ Keeping track of patient data over multiple visits

- ♦ Managing detailed, specifically-coded information
- ♦ Maintaining patient confidentiality and information security

Your career as a medical coder will require you to maintain excellent concentration and focus, no matter what environment you are in. On a day-to-day basis, you will be dealing with all types of patient charts, which you will need to code correctly and then send for billing to insurance companies. Possible places you might work as a medical coder include:

- ♦ Hospitals
- ♦ Physicians' offices
- ♦ Nursing care facilities
- ♦ Home health care services

The medical coding profession is also popular for those looking for self-employment. In this capacity, you may be consulting on-site at medical facilities or working remotely. Medical coders typically work remotely and partner with a health care facility that sends the information needed to code patient records and bill insurance companies.

SKILLS REQUIRED

However, medical coding is a competitive field, and to succeed, one must possess a number of critical skills. Everyone considering career in medical coding courses should possess, the following skills and abilities.

1. Attention to Detail

It is crucial that you never make a mistake in your coding or when submitting billing information. Even a minor error can lead to serious problems for patients or insurance companies. You must be able to keep a sharp mind and never lose your concentration while working to ensure that every detail, down to the tiniest piece of coding, is correct.

2. Discretion

In a medical coding position, you will be constantly handling sensitive patient information, and you have the responsibility for making sure that these details remain confidential. If you share the information with anyone, even a co-worker, you may be subject to a lawsuit. For this reason, it is necessary to be discreet, including when

requesting support from medical staff or other coders.

3. Computer Skills

Most of your work as a medical coder will involve using a computer. You should be comfortable using basic word processing and spreadsheet software as well as electronic health records and medical and coding software. You will be an asset to any health care service if you are able to learn quickly how to use new technology.

4. Organizational Skills

You may have to handle a large number of cases at the same time. Organizational skills will enable you to work efficiently, stay on track with tight deadlines, and send records to the correct places. This is particularly important for freelancers working at several medical centers.

5. Basic Understanding of Physiology

To convert information into the correct codes, you need to learn medical terminology. This means possessing a basic idea of human anatomy, physiology, and common diseases. You will also need to understand the concept and purpose of simple procedures. A degree in life science gives one an upperhand.

6. Writing Skills

Finally, you should be able to clearly express yourself in words, eliminating the risk of confusion in your reports. This means forming grammatically correct sentences, free from typos and spelling mistakes.

HOW TO BECOME A MEDICAL CODER? WHAT YOU NEED TO DO TO PURSUE A CAREER IN THIS FIELD?

Medical coding as a profession requires a lot of accuracy which comes with practice. A sound knowledge of the human anatomy and biology is very essential for performing the task of medical coding. Now, here comes a very important question: who can do medical coding or is there any eligibility criteria for the profession of Medical coding?

In most of the cases bachelor's degree in the life science stream is a must. For example: A bachelor's degree in Biotechnology, Microbiology,

Botany, Zoology, Physiotherapy, B.Pharma etc. Students with backgrounds other than science can also pursue a career in medical coding by taking courses and training from recognized institute or academics. As this profession involves organizing and maintaining medical information converting them into predefined codes, this job is well-designed as women are believed to be good at managing and organising things.

Those who have passed the certification courses in medical coding are eligible to apply to the post. Certification after graduation is much desirable for the said post. Adequate exposure in the area is also an essential eligibility to become a medical coder.

- ♦ Pursue graduation from a recognized educational institution.
- ♦ Obtain Certificate course in Medical coding or join any firm that offer training cum placement facility in the same
- ♦ Obtain relevant experience in the area.

In India, most of the firms prefer graduation as the necessary qualification for the post of Medical Coder. Certificate courses in medical coding will help one to get an entry in to the job. Along with this, candidate should possess proven experience in the area of medical coding. Bachelor degree in Medical Information Technology is the qualification required by international firms for the same post. Anyway, graduates with adequate skill and experience will also be considered for the same. It's also advisable to go for regular training than on-line training for professional trainings like medical coding.

SCOPE:

Healthcare industry is a fast growing industry; so as the career opportunities in the industry. The demand for Medical Coders is increasing all over the world day by day. The Commission is located at Gurgaon (Haryana). The Commission consists of a Chairperson and another Member. The post of Member in the above JERC will become vacant on 8.12.2019. It is proposed to fill up the above vacancy.

2. iii. That in any adjudicatory function of the State Commission, it is mandatory for a member having the aforesaid legal expertise to be a member of the Bench.

iv. The challenge to the appointment of the Chairman and Member of the Tamil Nadu State Commission is rejected as also the suo moto proceedings carried out by the Commission.

v. Our judgment will apply prospectively and would not affect the orders already passed by the Commission from time to time.

vi. In case there is no member from law as a member of the Commission as required aforesaid in para 2 of our conclusion, the next vacancy arising in every State Commission shall be filled in by a Member of law in terms of clause (ii) above."

Accordingly, the above anticipated vacancy on post of Member, JERC for Goa & UTs is to be filled up from persons, who, or have been holding a judicial office or are persons possessing professional qualifications with substantial experience in the practice of law, who have the requisite qualifications to have been appointed as a Judge of the High Court or a District Judge.

4. Member of JERC for Goa & UTs shall hold office for a term of five years from the date on which he/ she enters upon his/ her office or till he/ she attains the age of sixty-five years, whichever is earlier. 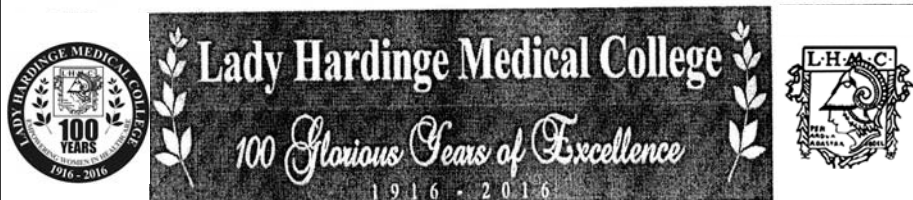

online portals for hotel and travel bookings. Travel portal Make My Trip reported a 186% jump in hotel bookings during the September quarter and its holiday package segment that includes hotel and flight bookings saw a 71% increase in revenues in 2018 over the same period of 2017.

India is a large market for travel and tourism. It offers a

diverse portfolio of niche tourism products - cruises, adventure, medical, wellness, sports, Meetings, incentives, conferencing, exhibitions (MICE), eco-tourism, film, rural, luxury tourism and religious tourism. India has been recognized as a destination for spiritual tourism for both domestic and international tourists.

In the hotel and tourism sector, 100 per cent FDI is allowed through the automatic route. A five-year tax holiday has been offered for 2, 3 and 4 star category hotels located around UNESCO World Heritage sites (except Delhi and Mumbai). Total FDI received by Indian hotel & tourism sector was US\$ 11.39 billion between April 2000 and June 2018. India is a large market for travel and tourism.

Under new visa policy tourists and business visitors are allowed to obtain a "visa on arrival" at sixteen designated international airports, by acquiring an Electronic Travel Authorization (ETA) online before arrival, without having to visit an Indian consulate or visa centre. Later the "visa on arrival" scheme was renamed "e-Tourist Visa" (or "e-TV") to avoid confusion. As a result of the new visa policy, 56,477 tourists

arrived on an e-Tourist Visa during October 2015, compared with 2,705 tourist arrivals during October 2014 (just before the facility was introduced), representing a 1987.9% increase. During the period from January to October 2015, a total of 258,182 tourists arrived on an e-Tourist Visa, a 1073.8% increase on the 21,995 tourist arrivals during the same period in 2014 (before the e-Tourist Visa was available).

Several branding and marketing initiatives such as 'Incredible India!' and 'Athiti Devo Bhava' have provided a focused impetus to growth. Fresh category of visa - the medical visa or M visa, has encouraged medical tourism in the country. The 'Incredible India Mobile App' assists the traveller to India and showcases major experiences for travelling. It is hoped that one per cent share in world's international tourist arrivals by 2020 and two per cent share by 2025 shall be achieved.

To conclude, already endowed with incredible natural beauty and a unique cultural heritage and diversity, India must take the advantage of 600,000 villages with their own cultures and heritage, ecotourism and cruise tourism to create unique experiences for travelers. Foreign tourist arrivals for medical purposes increased from 427,014 in 2016 to 495,056 in 2017(P). During January-November 2018, arrivals through e-tourist visa increased 41.50 per cent year-on-year to 2.06 million. As of 2017-18, 81.1 million people are employed in the tourism sector in India which

was 12.38 per cent of total employment in the country. Travel and tourism currently accounts for 9.6% of India's GDP (88% of which comes from domestic travel) and supports 9.3% of the country's total jobs (or 40.3 million jobs). Today, 12% of India's tourism GDP is derived from international tourism; it accounts for only 5.4% of the country's exports, compared to a global average of 6.6%. India's vast cultural and natural resources as well as its price competitiveness remain key drivers of its overall competitiveness. To increase and facilitate travel to India, the government has placed significant emphasis on ground transportation and international openness. Stronger visa policies and an e-tourist visa have produced an increase in arrivals from 103,617 in 2015 to 162,250 in 2016, a 56.6% growth.

Thus it has been found that tourism industry in India is growing fast and is expected to do even better in the coming years. In India, the travel industry hopes to create millions of job opportunities in next decade and this is the crucial sector where the government is pinning hopes of providing major employment opportunities by providing skill-based training programs for local youths and also to match the infrastructure to meet the international standards. Why not? India has everything - from over 7,000 km of coastline, and rain forests, deserts and snow-capped mountains to temples, mosques, wildlife, tribal habitation and a

multicultural population. With 29 states, 4,000 cities, a rich history and incredible diversity of culture, India's travel and tourism industry has tremendous potential to serve as an engine for economic growth, job creation and development.

India has one of the five fastest-growing aviation markets in the world. It plans to continue this growth to become the largest market by 2030, with passenger numbers reaching 278 million by 2026 and 442 million by 2035. Unlike many more mature tourist destinations, India has the opportunity to skip the trial-and-error phase many countries have had to undergo, and leapfrog to implement best practices and policies that have worked in other nations to ensure the growth of the travel and tourism industries. India's international arrivals are expected to reach 15.3 million by 2025, according to the World Tourism Organization which will offer numerous job opportunities in tourism industry. An ambitious target of 20 million foreign tourist arrivals (FTAs) by 2020 and double the foreign exchange earnings as well has been set. Tourism is a key sector to meet the overall objective of the faster economic growth and employment generation.
